Sub: Conduct of counseling by APDMC for admission to MBBS & BDS courses during academic session 2016-17.

Ref: Your letter No. APDMC/2016/977 dated 1.9.2016.

Committee took cognizance of your letter dated 1.9.2016 alongwith e-mails of other medical colleges regarding Conduct of counseling by APDMC for admission to MBBS & BDS courses for academic session 2016-17, in its meeting held on 02.09.2016.

Committee observed as follows:

As per Act “**Madhya Pradesh Niji Vyavsayik Shikshan Sanstha (Pravesh Ka Viniyaman Avam Shulk Ka Nirdharan) Adhiniyam, 2007**” dated 4th Aug, 2007 under the Chapter III, Section 6, it is mentioned that:

“6. In private unaided professional educational institution, admission to sanctioned intake shall be on the basis of the common entrance test in such manner as may be prescribed by the State Government.”

Further in the same Act, Chapter –V Section 12 & 13 reads as under:

“12. The State Government may, by notification, make rules for carrying out the purposes of this Act.

13 (1) The State Government may, by notification in the official Gazette, make regulations consistent with this Act and the rules made there-under."

Department of Medical Education has already published a Gazette Notification No. 355 dated 24.8.2016 with reference to the delegation of power conferred to the Department under the Act and has issued Admission Rules for Private medical institutes for MBBS & BDS course 2016-17. As such Medical Education Department has sole authority to conduct counseling for admission for 2016-17 session as per the Admission Rules issued by Department.

After observing above, Committee took decision that any effort to conduct a separate counseling is illegal and contrary to the provisions of the Act "Madhya Pradesh Niji Vyavsayik Shikshan Sanstha (Pravesh Ka Viniyaman Avam Shulk Ka Nirdharan) Adhiniyam, 2007" dated 4th Aug, 2007.
