**Subject: Refund of excess fees collected by Sukh Sagar Medical College and Hospitals, Jabalpur from the students admitted in MBBS Course in 2016-17.**

Shri Paritosh Shukla & others (120 students) admitted in MBBS Course in 2016-17 submitted an appeal before the Hon'ble Chairman, Admission and Fee Regulatory Committee on 20.08.2019 requesting to refund the excess fees collected by Sukh Sagar Medical College and Hospitals, Jabalpur from them consequent to the closure of the College. These students were re-allocated to other Medical Colleges of the State of Madhya Pradesh. The prayer of the applicants reproduced below:-


“It is, therefore, prayed that the Hon'ble Committee may kindly be pleased to direct the non-applicants to refund advance tuition fees of Rs.2,50,000/- , refundable caution money Rs.25,000/-, refundable hostel caution money of Rs.50,000/- and refundable library deposit of Rs.10,000/- to the applicants, in the interest of justice.”


The matter was put up before the Committee in its meeting held on 05.11.2020 and opportunity of hearing granted to you. In the hearing Mr.Brij Bhan Patel appeared before the Committee and requested to provide a list of the students and the amount reported to have been paid to the institution. On your request dated 05.11.2020, the copy of the Appeal was made available to you vide letter No.3331 dated 10.11.2020.



Thereafter, opportunity of further hearing was granted to you on 22.01.2021 wherein in place of Chairman/Director, an Advocate authorized by the institution appeared before the Committee through Video Conferencing. The representative of the institution could not give any satisfactory reply regarding refund of excess fees collected from the students. Instead he pointed out that the institution did not have the documents about the fees to be refunded.

As per decision of AFRC in the meeting held on 22.01.2021 you are hereby directed to refund the excess fees collected (As mentioned in Appeal dated 20.08.2019) from the students consequent to the closure of the College and re-allocation to other Medical Colleges of the State within 30 days from the date of issue of this order and report compliance to this office. The copies of complaints, Fee Receipt/RTGS detail etc. submitted by the students may be obtained (if required) personally from this office within seven days from the date of issue of this letter.


