**ORDER
(Date: 17th September, 2025)**

1. This appeal is filed under Sec. 10 of Madhya Pradesh Niji Vyavasayik Shikshan Sanstha (Pravesh Ka Viniyaman Avam Shulk ka Nirdharan), Adhiniyam, 2007 (hereinafter referred to as "Act of 2007") against the order passed by the Admission and Fee Regulatory Committee (AFRC for short) dated 11/07/2025, whereby the fee for the appellant institute was fixed at Rs. 15,000/- per student per semester for B.B.A. course being run by it, for academic session 2025-26.
2. It is submitted on behalf of the appellant that the impugned order is not a speaking order and there is no mentioning in respect of expenditure of the appellant institution. It is also submitted that as per para-4 of impugned order, in absence of audited data of F.Y. 2022-23, 2023-24 and 2024-25, the committee has regulated fees at Rs. 10,000/- per student per semester (Rs. 20,000/- per student per year), which is against the 'Technical Education

Framework 2025'. Therefore, it is prayed that the fee has regulated by AFRC may be increased up to minimum fee.

3. However, respondent supported the impugned order but he fairly submits that first time fee of the institute regulated by the AFRC and as per chart of minimum fee prepared by AFRC on 18.03.2025 for the academic session 2025-26 is fixed at Rs. 15,000/- per student per semester for the B.B.A. course. Therefore, minimum fee can be awarded in favour of the appellant. The respondent also filed Framework of Technical Education of Admission and Fee Regulatory Committee and chart of minimum fee of all technical courses for perusal of this Authority.
4. I have heard both the parties. Perused the record.
5. On perusal of aforesaid framework and minimum fee chart, it appears that there is minimum fee fixed at Rs. 30,000/- per student per year for B.B.A. course. It also appears that the committee has not mentioned any reason in the impugned order that why minimum fee has not been regulated for the appellant institution. There is also not mentioned in the impugned order that why less fee has been regulated from the minimum fee. Therefore, in view of this Authority, the impugned order is not sustainable.
6. Accordingly, the impugned order is partly set aside and appeal is allowed. Minimum fee, as fixed by AFRC for B.B.A. course i.e. Rs. 15,000/- per student per semester (Rs. 30,000/- per student per year) is awarded to the institution. Other charges fixed by AFRC shall remain the same.

This appeal stands disposed of accordingly.
