ORDER

(Date: 16th January, 2026)

1. This appeal is filed under Sec. 10 of Madhya Pradesh Niji Vyavasayik Shikshan Sanstha (Pravesh Ka Viniyaman Avam Shulk ka Nirdharan), Adhiniyam, 2007 (hereinafter referred to as “Act of 2007”) against the order passed by the Admission and Fee Regulatory Committee (AFRC for short) dated 25/08/2025, whereby the fee for the appellant institute was regulated at Rs. 20,000/- per student per semester for B.Pharma. course being run by it, for academic session 2025-26, 2026-27 and 2027-28.
2. The Chartered Accountant for the respondent present today.
3. It is submitted on behalf of the appellant that he had proposed fee at Rs. 30,000/- per student per semester and had uploaded documents as required by the respondent on its portal. However, by mistake, he had not uploaded particulars of amount of Rs. 96,68,867/- under head of 'general and administrative expenditure'. It is also submitted that as per order dated 18.12.2025 of this Authority, the appellant filed the particular of aforesaid expenditure. It is also submitted that fee as regulated by AFRC is at very lower side. The appellant is unable to run its course properly on regulated fee. Therefore, the it is prayed that the fee may be enhanced accordingly.

4. On the other hand, the respondent supported the impugned order, the Chartered Accountant of the respondent is also present. Copy of particular of aforesaid expenditure had been given to the C.A. of the respondent for calculation. He submitted that after calculation, fee can be enhanced from Rs. 20,000/- per student per semester to Rs. 26,900/- per student per semester (Rounded off to Rs. 27,000/- per student per semester). The respondent is also agree with its Chartered Accountant.
5. I have heard both the parties. Perused the record.
6. After considering the aforesaid facts and circumstances and submission of the parties, as the Chartered Accountant of AFRC has calculated the fee Rs. 26,900/- per student per semester (Rounded off to Rs. 27,000/- per student per semester). Therefore, in view of this Authority, fee regulated by AFRC for academic sessions 2025-26, 2026-27 and 2027-28 for B.Pharm course is enhanced from ₹ 20,000/- per student per semester to ₹ 27,000/- per student per semester. Other charges fixed by AFRC shall remain same.

This appeal stands disposed of accordingly.
